B. Frequency of Testing:

The goal of the Kent State University Drug Testing program is to test monthly during the academic year and potentially test at least one time in the summer months. The testing is done randomly for student athlete selection, performed when there is staff (athletic training staff) available to collect the samples; and the majority of the teams are in town. The specific policy follows this document as an attachment. Below is a listing of the test dates and the number of student-athletes tested at each test date.

C. Punishments related to positive tests (see attached policy):

1. All no-show positives are suspended until the required meeting with the physician of record in the drug testing program; after having had their respective coach informed and parents called; and must be tested- have all been completed. If this test is negative no other ‘punishment’ is merited. If this no-show positive follow-up test would be positive; then the student-athlete would have their second positive and be dealt with according to policy.
2. First-time chemical positives are suspended until the following has been completed: they are required to call their parents (or guardian) in the presence of their sport head coach. The student-athlete then must meet with the physician of record in the drug testing program, be tested, and scheduled to attend (at minimum) a university sponsored Drug Awareness Workshop at their

expense. These student-athletes are then placed back on the 'to be tested list' after skipping the next test date (unless last test of academic year), for the balance of their athletic career at Kent State University. The next test date is skipped to allow their system to purge any lingering traces of the chemicals shown positive.

3. Second-time positives are suspended for one calendar year from the date of notification of the positive drug test. If the student-athlete is on athletic financial aid they will lose the next two semesters of this athletic financial aid. They also are required to call their parents (or guardian) in the presence of their sport head coach. The student-athlete then must meet with the physician of record in the drug testing program and be scheduled to attend (at minimum) a university sponsored Drug Awareness Workshop at their expense. The physician of record may also require further counseling (either on or off campus). If the student-athlete plans on returning to their team at the end of the suspension, the physician may require a spot test at any time during the suspension.

D. Budget for drug testing:

1. The annual amount spent on drug testing has been in the range of \$6,500.00 to \$8,500.00.
2. Amounts will vary annually as the student-athletes are selected randomly.
3. Amount will also vary if steroid testing is added to the testing panel for a specific test date.

E. Audits or reports discussing the drug testing of student-athletes:

There have been no audits regarding the drug testing of student-athletes. All reporting has been done verbally, with the exception of the "DT Positives (9/2003 +) Current Only" report which is given to the SWA (Senior Women's Administrator) by the Associate Athletic Director: Medical Services/Head Athletic Trainer in order that she remain aware of those student-athletes that need to be included on each and every test date for the balance of their athletic career at Kent State University.

F. Contracts or agreements with vendors who have a role in drug testing athletes:

There is no specific contract/agreement with the testing vendor. The athletic department has done all testing through Aegis Analytical Laboratories since 2002.

G. All information provided by vendors the last time the institution put drug test of athletes up for bid or requested proposals:

The drug testing has never been place for formal bid or requested proposal.

According to the email received Thursday, August 2, 2007 from Jim Watson the preceding answers the questions asked by Mr Nate Carlisle of the Salt Lake Tribune.
