SUBSTANCE ABUSE AND EDUCATION

The Texas A&M Athletics Department does not approve of, excuse, or condone the use and/or abuse of illegal recreational drugs (e.g., marijuana, amphetamines, LSD, cocaine, ecstasy, heroin, PCP, etc.) by student-athletes. Furthermore, the Athletic Department does not permit or condone the use of illegal or banned performance enhancing substances (e.g. Anabolic steroids, ephedrine, etc.) or supplements that may contain banned substances (e.g. androstenedione, ephedrine, etc.). Through the administration of a drug-testing program, the Athletic Department hopes to provide a healthy atmosphere for student-athletes as they pursue academic and athletic success.

The objectives of the Athletics Department Substance Abuse and Drug Education Policy are as follows:

- 1. To educate student-athletes on the physical, psychological, social, ethical and legal consequences of banned or illegal drug use and abusive use of alcohol.
- 2. To maintain the integrity of the athletics program by emphasizing abstinence from the use of banned or illegal drugs, supplements, tobacco, and alcohol.
- 3. To provide preventative measures to discourage any student-athlete from drug experimentation and potential drug abuse or dependency.
- 4. To implement a drug-screening program coupled with disciplinary action for those who prove positive to further deter and identify potential users.
- 5. To offer rehabilitation and counseling services for any student-athlete who may have a drug or alcohol problem.
- 6. To abide by all University, Big XII Conference, and NCAA policies and procedures.

DRUG EDUCATION

Education is a valuable tool in life long prevention of substance abuse. The Texas A&M Athletic Department, through the Center for Athletic Academic Services and Life Skills Coordinator, will require mandatory:

- 1. Attendance of all incoming first year grant-in-aid student-athletes in a life skills class with a drug education component.
- 2. Attendance in at least **one (1)** of the 3-4 substance abuse presentations each academic year by all student-athletes (student-athletes are encouraged to attend as many presentations as possible). A list of these presentations/workshops will be made available through the Life Skills Coordinator each semester. Attendance will be monitored and reported to the respective coaches and athletic administrators. Failure to comply with the above mentioned educational opportunities would result in increased educational requirements for the student athlete. Other educational information will be presented in the form of poster and current event information that will be posted on athletic training room/dressing room bulletin boards.
- 3. Student-athletes are advised to avoid use of over-the-counter medications and supplements without first consulting the respective team physician and athletic trainer. Supplements are not regulated by the FDA; and therefore, labeling of the items in the supplements is not necessarily the ingredients in the supplement. While the products are not illegal to purchase, they very well may be banned or be harmful to health. False positives, as well as positive tests for banned substances, can result from the use of these products. The National Center for Drug Free Sport offers a free service regarding questions about the banned status of any medication or supplement via the Dietary Supplement Resource Exchange Center (REC). The Center provides instant access at www.drugfreesport.com/rec.

DRUG TESTING PROTOCOL

Substance Abuse Committee

The substance abuse committee is responsible for the implementation of all drugtesting policies. The committee will work with the coaches, staff and student-athletes to revise and update the policy as necessary. The substance abuse committee will be approved by the Director of Athletics and will consist of the following standing members: Senior Associate Athletics Director for Student Development, Assistant Athletics Director for Athletic Training, Associate Athletics Director for Athletic Academic Affairs, Student Counseling Service Alcohol and other Drug Specialist, Team Physician, Life Skills Coordinators, Senior Womens Administrator, Sport Administrator and University Psychologist. Addendum members will include the Head Coach for each of the respective sports. The standing members of the committee will meet monthly to

discuss drug awareness and testing issues. The addendum members will be invited to all meetings with the exception of those meetings involving a positive testing sanction or appeal cases in which only the involved sport head coach and administrator will be included and serve as voting members. The athletic trainer may be asked to sit in on appeals hearings as an ex-officio, resource member. The Substance Abuse Committee, as described above, will also hear appeals and determine sanction plans for drug policy violators, as dictated by the policy.

Who will be tested

All rostered student-athletes (male & female) grant-in-aid and non-grant-in-aid, with participation eligibility remaining, will be subject to testing. This will also include red shirted, ineligible rostered athletes, as well as those that sustain a season ending injury, provided they have eligibility remaining. Medical grant-in-aid student-athletes will be excluded.

Drugs Subject to Testing

The primary focus of the Texas A&M Policy is to deter and identify problems associated with use of illegal drugs, performance enhancing drugs, and illegal use of prescription drugs. Therefore, the following classes and specific drugs are subject to testing. New drugs may be included at any time to the list by the Substance Abuse Committee without prior notification. The Committee reserves the right to determine a subset of drugs from the below listed category for testing based on current nationwide concerns.

- Alcohol
- 2. Depressants: Barbiturates, methaqualone, benzo diazapines and heroin
- 3. Hallucinogens: LSD, PCP
- 4. Performance enhancers: Anabolic steroids, all classes, banned supplements (androstenedione, ephedrine, etc.)
- 5. Stimulants: Amphetamines, methamphetamines, cocaine, MDMA(ecstasy), ephedrine
- 6. Tetrahydrocannabinoids (Marijuana, hashish)

Confidentiality

- 1. The collection and coding of specimens are executed in a manner to insure total confidentiality and proper identification.
- 2. Positive analysis results are returned to the Assistant Athletics Director for Athletic Training, Senior Associate Athletics Director for Student Development, Director of Athletics, and student-athlete's head coach, and/or assistant coaches, as deemed necessary, student-athlete's sports administrator, Senior Coordinator for Alcohol and Drug Education Program, if necessary the other members of the Substance Abuse Committee and parents, with the student-athlete's permission.
- 3. All Testing results are returned to the Assistant Athletic Director for Athletic Training for filing in the athlete's confidential drug testing file.

Selection Process For Testing

1. <u>Announced testing</u>

Every male and female student-athlete participating in a sport at Texas A&M University will be tested when they report for participation in the fall semester.

2. Random Testing

Random testing will take place during the fall and spring academic year, as well as the summer sessions, for all those enrolled in school. A random list of sports will be selected for testing. Then a random list of student-athletes' names will be computer generated for the sports selected. The procedure will be as listed below in the Collection Procedures.

3. <u>Team Testing</u>

Each team will be subject to testing of all of its student-athletes, as a team, at any time.

4. Reasonable Suspicion

Student-athletes may be selected for testing for reasonable suspicion at any time. Such causes for reasonable suspicion include, but are not limited to, reports of illegal drug use, legal implications for drug use, unusual behavior or academic performance, noticeable change of physical appearance (abnormal weight changes, strength gains, etc.) and previous positive drug testing.

5. Follow up testing

Student-athletes who test positive on any drug test administered by TAMU Athletics Department, NCAA or the Big XII will be subject to follow-up testing, at any time, to determine that compliance with policy offense sanctions is being maintained.

Collection Procedure

The collection of urine samples from the student-athletes shall be taken under the supervision of an independent member of the Drug Collection Team. The collection team will be trained in the appropriate collection procedures by and for Aegis Laboratory. Every possible step will be taken to insure the integrity of the sample and appropriate chain of custody. The general procedure utilized in the collection process for random testing will be as follows:

- 1. The computer will randomly select student-athletes. Some sports will require customization for random selection.
- 2. Collectors will coordinate with the coach or designee of each sport to designate an appropriate time before, during or after practice or event.
- 3. The collector will coordinate with athletic trainer or sport designate for each sport to identify the selected athletes.
- 4. The athlete will proceed with the collector to submit a witnessed sample.
- 5. The sample will be sealed and packaged. The paperwork will be completed in clear view of the athlete. Samples are numbered, and no names are placed on the specimen to insure confidentiality.
- 6. Sealed samples will then be refrigerated under the supervision of one of the Staff Athletic Trainers, who will contact the designated overnight carrier for pickup and delivery to Aegis Analytical Laboratory for screening and confirmation.
- 7. Results will be returned to the Assistant Athletic Director for Athletic Training within 48 hours following receipt of the specimens at the laboratory, with positive screen confirmation returned within 5 days from delivery to the Laboratory.

SAFE HARBOR PROGRAM

(Allows for self reporting of substance problem without penalty)

A student-athlete eligible for the Texas A&M University Safe Harbor program may refer himself or herself to the Program for voluntary evaluation and counseling. A student is not eligible for the Program after he or she has been informed of an impending drug test or after having received a positive Texas A&M University, Big XII or NCAA drug test.

Texas A&M University will work with the student-athlete to prepare a Safe Harbor treatment plan, which may include confidential drug testing. If the student-athlete tests positive for a banned substance upon entering the Safe Harbor Program, that positive test will not result in any administrative sanction unless the student-athlete tests positive in a subsequent retest or the student-athlete fails to comply with the treatment plan. (The team physician may suspend the student-athlete from play or practice if medically indicated.) A student-athlete will be permitted to remain in the Safe Harbor Program for a reasonable period of time, not to exceed thirty (30) days, as determined by the treatment plan. A student-athlete will not be permitted to enter the Safe Harbor Program thirty (30) days prior to NCAA or Conference postseason competition.

If a student-athlete tests positive for any banned substance after entering the Safe Harbor Program or fails to comply with the Safe Harbor treatment plan, the student will be removed from the Safe Harbor Program. An initial Safe Harbor positive test will be treated as a first positive and a subsequent positive as a second positive, subject to the sanctions explained in this policy.

The Substance Abuse Committee may be informed of the student-athlete's participation in the Safe Harbor Program. The athletic trainer assigned to that sport may also be notified, if medically appropriate. The assistant coach(es) also may be informed, at the discretion of the head coach. Other university employees may be informed only to the extent necessary for the implementation of this policy.

SANCTIONS AND PROCEDUERES FOR POSITIVE TESTING

First Offense

Sanction

Student-athletes testing positive for recreational or street drugs may be suspended from the current or next available regular season contest. The athletic administrator

and head coach, in consultation with the Assistant A.D. for Athletic Training and the appropriate counseling authorities, will determine student-athlete discipline or suspension.

Anabolic Steroid or Performance enhancers:

Student-athletes testing positive for Anabolic steroids or banned performance enhancers will be suspended immediately. The Substance Abuse Committee, with approval from the Director of Athletics, will determine reinstatement.

Procedures:

- Counseling-All scheduling will be done through the University Student Counseling Service. The counselor will determine the term of the counseling sessions. The counseling sessions are <u>MANDATORY</u> and will be monitored for attendance. Failure to attend sessions may result in additional suspension.
- 2. Mandatory assessment and education.
- 3. Follow up testing, at anytime, in addition to normal random testing for a minimum of one year from the date of positive test.
- 4. The student-athlete's parents or guardian will be notified, providing the student-athlete has previously completed a drug testing parental notification release.

Second Offense

Sanction:

Student Athletes testing positive a second time for street or recreational drugs will be subject to the below listed sanctions:

- 1. Probation for remainder of athletic eligibility
- 2. Individual sport discipline
- 3. Possible suspension from participation
- 4. Loss of grant-in-aid may result
- 5. Potential permanent suspension from participation

Anabolic Steroid or Performance enhancers:

Student-athletes testing positive a second time for Anabolic steroids or banned performance enhancers will be suspended immediately, in addition to the other listed sanctions and procedures.

Procedures:

- 1. Meet before the Substance Abuse Committee to explain reason for offense.
- 2. Substance Abuse Committee then will determine individualized plan for education, medical assessment, rehabilitation, sanctions and other discipline determined to be beneficial (e.g. community service, spiritual counseling, etc.).
- 3. A contract will be drawn up with the approved individualized plan and signed by the student athlete, Head Coach and Director of Athletics. The contract will be filed in the student-athlete's confidential file.
- 4. The student-athlete's parents or guardian will be notified, provided the student-athlete has previously completed a drug testing parental notification release.
- 5. Follow-up testing, at anytime, in addition to normal random testing, for the remainder of career at TAMU.

Third Offense

Student Athletes testing positive for a third time following completion of the second offense contract will be subject to the policies listed below:

Sanction:

- 1. Immediate suspension from all participation (see procedure #1).
- 2. Athletic participation may be terminated.
- 3. Grant-in-aid privileges may be terminated.

Procedures:

1. After the completion of an approved drug rehabilitation program, the studentathlete may be eligible for reinstatement. The drug rehabilitation program is the financial responsibility of the student-athlete, first. The Director of Athletics must approve any expense incurred by the Athletic Department.

- 2. The Substance Abuse Committee, with the approval of the Director of Athletics, will recommend reinstatement.
- 3. The student-athlete's parents or guardian will be notified, providing the studentathlete has previously executed a drug testing parental notification release.
- 4. An appeal to the above sanctions and procedures may be made to the Substance Abuse Committee for consideration.

ALL OFFENSES ARE CUMILATIVE

All offenses are cumulative for the student-athlete's enrollment at Texas A & M University.

APPEAL PROCESS

- 1. If the student-athlete believes, and has specific facts or circumstances that may come into play regarding error of his/her third offense sanction, the student-athlete may file a written appeal with the Director of Athletics within 15 days after notification of positive test resulting in Third Offense
- 2. The appeal may include only new factual information not previously available. This information should be presented, along with the request for appeal.
- 3. The Director of Athletics will review the information and determine if an appeal hearing should be convened with the Substance Abuse Committee. If a hearing is warranted, it will be scheduled as soon as the committee can be convened or at the next regularly scheduled meeting of the committee.
- 4. The student-athlete shall have the right to have present counsel of his or her own choosing, although counsel may act in an advisory capacity only and not in the presentation of the case. If counsel will be present, the student-athlete must notify the Director of Athletics at least 48 hours before the hearing.
- 5. Immediately after hearing the appeal, the panel will hold a closed session for deliberation. At the conclusion of the deliberations, the student- athlete will be orally informed of the committee's decision. The findings of the Substance Abuse Committee will be final and noted in the student-athlete's confidential file.

GENERAL PRINCIPLES

- 1. Upon arrival each school year, every student-athlete will be given a copy of the TAMU Athletic Department Substance Abuse & Education Policy. All student-athletes will review the policy. After the review, a question and answer session will be held to assure understanding of the policy and how it will be conducted. Student-athletes will acknowledge with a signed statement following the review, and question and answer session.
- 2. Any student-athlete found selling, in the possession of any illegal drug or drug paraphernalia shall be reported immediately to the proper law enforcement authorities. The student-athlete may lose athletic grant—in-aid privileges and be removed from all participation, along with any other sanctions required the University and Director of Athletics.
- 3. Any drug not included specifically in Part II, Section C, is subject to inclusion by the Substance Abuse Committee. Any use of performance enhancing drugs as classified by the NCAA or the Big XII, are also subject to the sanctions of this policy.
- 4. A positive test by the NCAA or the Big XII will be considered as an offense against this policy. Sanctions will be implemented by the appropriate governing policy. Procedures will be implemented in accordance with the appropriate offense of this policy.
- 5. Any change or deviation from this policy must be recommended by the Substance Abuse Committee and approved by the Director of Athletics.








Three-Year Positivity Rate Comparison Chart







Three-Year Positivity Rate Comparison Chart






