>RESPONSE: Our drug testing is done on a random basis throughout the
>academic year. As noted below, all drug tests are administered on a
>trade-out agreement with a local laboratory so our frequency and the
>number of drug tests that we will administer is predicated on the
>amount
>of tests that we have available through trade. The NCAA now tests
>on a
>year round basis and during the summer months, which has helped us
>reduce
>our number of tests.

>Psychological Services. Those records are confidential. Attached is
>our
>drug testing program policies and procedures, which outlines the
>punishment phase of the program.
